# Rule and Regulations

1. Name: The name of the 'Society' shall be "Managing Committee Balangir Public School" sponsored by Lions Club Balangir with its premises and head-quarters situated at Balangir. All the meetings of the School shall be conducted inside the School premises or in the Balangir Lions Club Office.

2.Location :- At/PO- Dist - Balangir .
3.Objects of the Society :-

- (a) To promote and develop the Public School sponsofed by Lions Club, Balangir in the line with the Central School
- (b) To promote, develop and encourage the standard of Educational Literary and cultural activities among the students of the school;
- (c) To advance and improve the interests of games and sports among the students of the school;
- (d) To promote social activities among the students of the school;
- (e) and such other actitivities and objects which may be conducive to and beneficial for the educational development of the school.

#### GENERAL BODY

4. The general body of the school shall be the general body of the Lions Club Balangir and Wembers from outside taken in the managing committee of the school, the principal of the sector and one representative of the teachers.

5. MEMBERSHIP: The members of the Lions club
Balangir and nototary members taken into the
Managing Committee from among the Public irrespective
of Caste and creed of the school including the
Principal of the School and a teachers, representative
shall be the members of the Managing Committee.

#### 6. CHASATION OF MEMBERSHIP :-

The membership of a member of the School shall be ceasured for any of the following grounds:

(a) By regignation; (b) If he ceases to be a member of the Lions Club Balangir; (c) by disciplinary action taken against the member concerned; (d) whose name has been deleted from the membersance accented; amembership of the Managing Committe by the Lions Club, Balangir.

# 6. RIGHTS AND PRIVILEGES :-

Subjects to the provisions of these rules of Nembers or any Bye law of the school, a member shall have amongst other, these following rights:

- \* Right to vote and seek election to the managing committee excepting to the post of President, Vice-President Secretary, Treasurer and Convenor.
- 7. <u>Hanagement</u>: The management of the School, its affairs, administrations enforcement of rules and regula**tions** and Bye-laws shall be entrusted with the managing committee of the school.
- 8. THE MANAGINA COMMITTEE SHALL BE CONSTITUTUED AS FOLLOWS:(a) PRESIDENT:- The President of the Lions Glub shall be
  the President of the School.

#### 8. (a) POWER AND FUNCTION OF THE PRESIDENT :-

The President shall be the head of the School for all purposes. It shall be his duty to preside over all meetings and function of the school. He shall have the power to preserve order in the meeting.

(B) VICE PRESIDENT: The first Vice-President of the Lions Club shall be the Vice-President of the School .

POWER AND FUNCTION OF THE VICE PRESIDENT:-

In the absence of the President he shall have all the power of the President.

- C) SECRETARY: The Secretary of the Lions Club shall be the Secretary of the School .
- (a) POWER AND FUNCTION OF THE SECRETARY :-

The Secretary shall subject to the General control and direction of the Managing Committee interectes; (a) Convene all meetings and shall cause minutes of all proceedings, resolutions in a book specially provided for the purpose and shall get it signed from the President or the Vice-President.

- (b) Conduct all correspondences of the School. He may delegate some specific correspondences to the Principal of the School.
- (c) He shall be incharge of all records, documents and properties of the school.
- (d) Sue or be sued on behalf of the School.
- (e) Take action in accordance with the decision of the General body meeting, managing committee meeting and Sub-committee

#### (d) Treasurer :-

The Treasurer of the Lions Club shall be the Treasurer of the School.

# (a) POWER AND FUNCTION OF THE TRESURER :-

The Treasurer subject to the general control of the Managing committee inter-alies. He shall regulate all financial transactions in respect of the school and shall be guardian of its funds. He shall withdraw money from the bank with joint signature of himself and the Secretary. He shall maintain the accounts book.

# B(a)

Prepare and place the Budget Estimate of the School before the General Body meeting.

(b) Cause the account of the school to be duly audited and place the same before the General Body meeting.

- (c) Deposit all money as and when received from the Principal of the School and from other sources to the accounts of the school with the Bank in two days time excluding the holidays it comes on the date of receipt and on preceeding days.
- (e) Have charge of the funds of the school.
- (f) Operate Bank Accounts of the school in conjunction of the Secretary of the School.
- (g) Allow withdrawal of money from time to time as per the requisition of the Secretary and duly approved by the President .
  - (E) CONVENOR: The Chairman of the Education Committee of the Lions Club shill be the Convenor.

#### (a) POWER AND FUNCTIONS OF THE CONVENOR :-

He shall be the Chairman of all Sub-Committee meeting look after and regulate admission of students; arrange cultural and literary activities among the students of the school through the Principal.

# BANKING ACCOUNTS :-

An account shall be open in the name of the School in any of the schedule Bank at Balangir and the account shall be regulated by the Secretary and the treasurer jointly under the supervision of the President.

# (F) MEMBERS :-

Out of the six members, two will be nomited by the Glub from amongst its members and there shall be two as the 'Guardians' representatives and the rest two shall be the principal of the School and a teacher's representatives.

# 9. TERM OF OFFICE :-

The office bearers and the members of the managing committee shall held office for a tenure of one year.

# 10. TA CA NCY :-

The office of the office bearers of members shall fall vacant (a) if he/she ceases to be a member of the Lions Club or that of the Managing Committee(b) if she/he resigns from his/her post.

The President shall have the power to fill-up any such vacancy by as co-option and such action will hold

#### 1 1 . MERT INGS :-

- (a) General Body: The general body meeting of the Lions club shall be the general body meeting of the general body meeting of the general body meeting of the school and the same shall be conducted as per the Rules, Regulartions and code of ethics of the Lions club where the following business shall be transacted.
- (i) Consideration and adoption of annual report concerning the school placed by the Secretary.

  (ii) Confirmation and adoption of audited statement of accounts.
- (iii) Budget for the following year .
- (iv) Election of members to the managing committee.

  (v) Amendments if any of the rules of the school for which due notice has been given to the Secretary before one month of the general body meeting or official amendments circulated by the Secretary before fifteen days of the general body meeting.

# 11. (b) APPOINTMENT OF AUDITOR :-

The Accounts of the school shall be audited every year by one or more Auditor appointed by the General Body. The audited Accounts and Exependiture shall be placed before the General Body meeting for approval. The Accounts will also be opened for audit by the Auditor of the Government.

# 12. A MNUAL DAY CELEBRATION :-

The Annual day celeberation must be held every year on the date and time fixed by the managing committee.

# 15. ELECTION :-

# 16. VOT ING :-

Every matter arising in any meeting shall be decided by majority of votes and in case of tie the President, shall have a casting vote. Voting shall be conducted by show of hands or by secret ballot as decided by the President.

- 17. POWER AND FUNCTION OF THE MANAGING COMMITTEE: The power and functions of the managing committee
  shall be as follows:-
- (a) The management of the business and affairs of the school shall be vested with the managing committee and it will carry out the objects as specified in the memorandum of association.
- (b) To contitute the following committees: (i) appointment and fixation of scale of pay of the school staff (ii) Disciplinary action and grievances sub-committee(iii) purchase and finance Sub-Committee.
- (c) To make all arrangements for the celebration of annual day of the school.
- (d) To manage and administer the funds of the school.
- (e) To procure, accept, and receipt donation, fights, grants in a language and lang
- (f) To incure expenditure provided in the Budget of the School.
- (g) To dispose of rejected materials of the school.
- (h) To do all such acts as are incidental and conductive to the doing foregoing acts or any of them.

# 18. SPECIAL GENERAL BODY MEETINGS :-

Special General Body Meeting can be called at any time either by the Secretary or by a decision of the Managing Committee for specific purposes or as per the rules of the Lions Club, Bulangir. It shall be called with in fifteen days from the date of such decision by the managing committee. Matters for which the meeting has been called can only be discussed in such meeting.

The managing committee of the School is empowered to form Bye law for the functioning and for the administration of the School like admission of students, Disciplinary action against misconduct of students, Teacher school year, Holidays, Examinations and all other thing concerning smoothing functioning of the school and the same By-law shall be binding for all.

# 23. INTERPERTATION :-

The Managing Committee is the final authority for interpretation of Rules and Bye Laws and shall be binding for all members.
